### FEEDING DIRECTIONS

Hand feed continuously at the rate of 5 pounds per head per day to provide 150 mg Lasalocid and 350 mg Chlortetracycline per head per day. Provide adequate amounts of roughage (pasture or hay). Consult **ROWE NUTRITION LLC** for questions or more specific feeding instructions.

**CAUTION:** The safety of Lasalocid for use in unapproved species has not been established. Do not allow horses or other equines access to feeds containing Lasalocid.

**WARNING:** A withdrawal time has not been established for pre-ruminating calves. Do not use in calves to be processed for veal. Contains high level of copper do not feed to sheep or other species sensitive to copper.

### ADDITIONAL RECOMMENDATIONS

- Use Cates Creep for calves still nursing the cows for maximum gain, body volume and the additional health benefits of Lasalocid and Chlortetracycline.
- Fresh water should be available at all times.
- Free choice hay or pasture should be available at all times. Grass hay or pasture is preferred, Alfalfa hay or pasture is not recommended.
- If hay is restricted a minimum of 1 flake AM & PM should be fed.
- Provide free choice salt in loose or block form.
- Free choice mineral should be made available if not on full feed.
- Additional fats and oils should not be added to this product.
- **ROWE ENHANCE** is recommended as a top dress but is not mandatory.
